3. Scholarship recipient will be required to submit a report of 250-500 words describing his or her experience from the FAE Seminar and the likely impact on his or her academic and/or professional goals.
4. Scholarship recipient will be required to send three high resolution digital photographs taken during the seminar and showing the recipient's participation in the program.

The \$500 scholarship will cover the cost to attend the seminar (\$395) as well as an additional \$105 in travel expenses such as a hotel or flight.
